1st passage

Magistrates' Courts

Cases in magistrates' courts are heard by either three magistrates or a district judge. There is not a jury in a magistrates' court.

This court normally deals with cases which are known as 'summary offences'. Examples of these are:

motoring offences,
minor criminal damage,
being drunk and disorderly.

It sometimes deals with more serious offences such as burglary and drug offences.

The type of punishment given by a magistrates' court could be up to six months in prison, a fine of up to £5,000 or a community sentence (for example, a fine and unpaid work in the community).
